Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the Respondents No.2 and 3 in not taking any action on Representation dt.14.6.2021, not applying the Rehabilitation and Resettlement Package for acquisition of house and land for an extent of Ac.0.02 1/2, gts, situated at Sy.No.853/17 of Ramanujavaram Village of Manuguru Mandal, Bhadradi Kothagudem District, is as illegal arbitrary and violation of the principles of natural justice, and consequently direct the Respondent No.2 and 3 to pay the compensation by applying the Rehabilitation and Resettlement Package, house and land for an extent of Ac.0.02 1/2, gts, situated at Sy.No.853/17 of Ramanujavaram Village of Manuguru Mandal, Bhadradi Kothagudem District, in the interest of justice and equity.

ORDER:

Heard learned counsel for the petitioner and the learned Government Pleader for Land Acquisition appearing for the respondents.

2. In this writ petition, the petitioner is aggrieved by the action of respondent Nos.2 and 3 in not taking any action on his representation dated 14.06.2021, seeking Rehabilitation and Resettlement Package for acquisition of his house and the land to an extent of Ac.0.02 ½ gts in Sy.No.853/17 situated in Ramanujavaram village of Manuguru Mandal, Bhadradri Kothagudem District,

3. Having regard to the fact that the petitioner has already submitted a representation dated 14.06.2021 to respondent No.3 ventilating his grievance, without going into the merits or demerits of the case, the writ petition is disposed of with a direction to respondent No.3 to consider the said representation and pass necessary orders strictly in accordance with law. It is needless to mention that before passing any orders, the petitioner shall be put

on notice and given an opportunity of hearing. The entire exercise shall be completed within a period of eight weeks from the date of receipt of a copy of this order. No order as to costs.

Pending miscellaneous petitions, if any, shall stand closed.
