Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, order or direction more in the nature of Mandamus, declaring that the petitioner is entitled to be allotted to Peddapalli District Multi Zone-I as Staff Nurse under spouse grounds and in terms of Telangana Public Employment (Organisation of Local Cadres and Regulation of Direct Recruitment) orders 2018 issued Vide G.S.R 820 (E) dated.29/08/2018 and consequential order under G.O.Ms.No.175 dated.04/08/2021, G.O.Ms.No.175 dated.04/08/2021 and also in terms of Para 13 and 23 of the Appendix to G.O.Ms.No.317 dated.06/12/2021 and non-consideration of his preference for allotment to Peddapalli District Multi Zone-I, is illegal, arbitrary and violation of Art.14, and 61 of Constitution of India and consequently direct the Respondents to allot the Petitioner to Ramagundam Medical College, Peddapalli District, Multi Zone-I, without insisting in the interest of justice.
