Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly, one in the nature of Writ of Mandamus, by declaring the action of the 3rd respondent in not receiving and to register and release the gift deed presented by the petitioner in respect of the piece and parcel of the Plot No. 12, admeasuring 201.80 Sq.Yards, Plot No. 13, admeasuring 190.00 Sq.Yards, Plot No. 14, admeasuring 178.00 Sq.Yards and Plot No. 15, admeasuring 202.50 Sq.Yards, totally 772.30 Sq.Yards in Sy.No. 226, situated at Cheeryal Village, Keesara Mandal, Medchal-Malkajgiri District, Telangana State, on the basis of Memo No.G2/257/2019, issued by the 2nd respondent as illegal, arbitrary, unlawful, without jurisdiction and contrary to the provisions of the Registration Act, 1908 and in violation of Article 14 of Constitution of Indian and consequently to direct the 3rd respondent to receive, register and release the gift deed presented by the petitioner in respect of above

said property, notwithstanding the Memo No.G2/257/2019, issued by the 2nd respondent.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the 3rd respondent to receive, register and release the gift deed presented by the petitioner in respect of the piece and parcel of the Plot No. 12, admeasuring 201.80 Sq.Yards, Plot No. 13, admeasuring 190.00 Sq.Yards, Plot No. 14, admeasuring 178.00 Sq.Yards and Plot No. 15, admeasuring 202.50 Sq.Yards, totally 772.30 Sq.Yards in Sy.No. 226, situated at Cheeryal Village, Keesara Mandal, Medchal-Malkajgiri District, Telangana State, without reference to Memo No.G2/257/2019, issued by the 2nd respondent, during the pendency of the above writ petition.

ORDER:

Heard both sides and perused the material on record.

2. It is submitted by the learned counsel on either side that subject matter of this Writ Petition is squarely covered by the Common Order passed by this Court in W.P.No.328 of 2022 and batch dated 18.02.2022 as modified by the Order dated 22.02.2022 in I.A.No.2 of 2022 in W.P.No.2985 of 2022 and batch, as such, this Writ Petition may be disposed of in terms thereof.

3. Therefore, following the Common Order dated 18.02.2022 in W.P.No.328 of 2022 and batch as modified by the Order dated 22.02.2022 in I.A. No.2 of 2022 in W.P.No.2985 of 2022, in terms thereof, this Writ Petition is disposed of as under without any order as to costs:

(i) The respondent - Sub-Registrar is directed to register the document of sale, transfer and gift etc., presented for registration by the petitioner/s without references to the Memo Nos.G2/257/2019 dated 26.08.2020 and 29.12.2020 issued by the respondent - the Commissioner and Inspector General of Registration and Stamps, Telangana; Letter No.45/TP/NMC/2019 dated 01.11.2019 issued by the respondent - the Commissioner, Municipal Corporation, Nizampet to the respondent - the Sub Registrar, Quthbullapur, Ranga Reddy District, and similar letters, if any, issued by the various Municipal Commissioners in the State;

(ii) the Sub Registrars in the State shall make an endorsement at the reverse side of the first page of the document referred in direction No.(i) that registration so done is subject to outcome of SLP (Civil) No.19695 of 2021 filed by the State Government before the Hon'ble Supreme Court; and

(iii) in case, it is found that there is any violation of law like plots / lands / structures being sold form part of F.T.L. and Buffer Zone / Plots having less than 30 feet road width access, the Sub Registrar shall make an endorsement informing / cautioning the purchasers that risk is involved in purchase of such plots; such transactions are hit by relevant statutory provisions; that registration of the same is subject to outcome of orders of the Hon'ble Supreme Court in SLP (Civil) No.19695 of 2021. To that effect, an endorsement shall be made on the reverse side of the first / second page of the document and also in the . encumbrance record, website etc.

The miscellaneous petitions pending, if any, shall stand closed.

There shall be no order as to costs.
