Declaring the inaction of Respondents more particularly Respondent no.2 herein in not removing the Petitioner's land admeasuring to extent of Ac 3-00 in the Sy.no. 303/2 situated in the Venkatapur Village, Duggondi Mandal, Warangal District from Prohibitory property list prepared u/sec 22A of the Registration Act,1908 in pursuance of the application of the Petitioner dated.06.11.2021 as being illegal, arbitrary, unjust and against the provisions of the Registration Act, 1908 b. Consequently, direct the Respondent no.2 to the remove the Petitioner's land admeasuring to an extent of Ac 3-00 in the Sy.no. 303/2 situated in the Venkatapur Village, Duggondi Mandal, Warangal District from Prohibited Property list;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SMT. L VANI Advocate for the Petitioner, GP FOR REVENUE who takes notice for the respondents, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

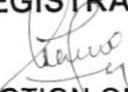
GP for Revenue seeks time to get instructions.
