Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased ~~to be pleased~~ to issue a Writ. Order or Direction more particularly one in the nature of Writ of Mandamus, to declare the action of the respondents in i) Rejecting the application of the petitioner vide application no. 2100077205, dated. October 2021 and ii) Not considering the fresh application no. 2100119853 dated. 12/11/2021 to remove the property of the petitioners deceased mother from prohibited list in Survey No.21Aa2 to an extent of Ac.4.12 guntas situated at Arekodu village. Khammam Rural Mandal, Khammam District and iii) Not receiving the application for Succession of the said property in the name of the petitioner herein is highly illegal, arbitrary besides violating petitioners rights under Article 14 of the Constitution of India and is in violation of Sec(5) of the Telangana Rights in Land and Pattadar Pass books Act 2020 , and against settled principles of law and consequently direct the respondents to delete the property of the Petitioners mother from prohibited list and receive the application for Succession of the said property in the name of petitioner.
