Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the Proceedings No. 887/OP/A2/2021 dated 26/11/2021 issued by the Respondent reducing Petitioner pension from Rs. 40,000/- to 30,320/- as illegal, arbitrary and against to the Principles of Natural Justice and violative of Article 14 and 21 of Constitution of India and set aside the same and also set aside the consequential proceeding 3103/u/pension/2007 dt.09/12/2021 and consequently direct the Respondent not to deduct the amounts from pension of the Petitioner.;
