Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction more in the nature of Writ of Mandamus declaring the award registered as Lok adalat case No 1056 of 2021 in OS 164 of 2018, dated 27/12/2021 on the file of the 1st respondent as illegal, arbitrary, null and void and against the principles of natural Justice and to set aside the same.
