POT) Department Dt.16.02.2008 in respect of the land in Sy.No. 391/A, admeasuring Ac.1-30 guntas, situated in Alwal Village and Mandal, Medchal-Malkajgiri District as illegal, arbitrary, against the order of the Hon'ble High Court passed in PIL No.517 of 2013 and against principles of natural justice and against all settled principles of law and consequently direct the respondents to consider the Objection Petition made by the petitioner dt. 26.04.2022, requesting the Respondents for cancellation of conveyance deeds made under GOMs 166, Revenue (Assn. POT) Department Dt.16.02.2002 in respect of the land in Sy.No.

391/A, admeasuring Ac.1-30 guntas, situated in Alwal Village and Mandal, Medchal-Malkajgiri District
