WRIT OF MANDAMUS declaring the action of the respondent No.2 in not revoking the proceedings No. 3987/Sand/PL2015 dated 22/4/2022 de-casting of sand from the lands of respondents 9 to 11 in Sy.Nos. 02, 03 of Thatikole Village, Devarakonda Mandal, Nalgonda District over an extent of Acres. 4-32 gunts by M/s Telangna State Mineral Development Corporation Ltd., For a quantity of 38,648 M3 is illegal, arbitrary, violation of TS Mining rules and violation of Fundamental Rights guaranteed Under the constitution of India and violation of Article, 21 of the Constitution of India and consequently set aside the same,
