WHEREAS the Petitioner above named through his Advocate Sri C RAJA SEKHAR REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order of direction, preferably one in the nature of Writ of Mandamus and to declare the impugned orders in Memo No.SPL/Secretary Peshi/2021-409, dt.13-5-2022 of the 1st respondent in rejecting

the case of the petitioner for re-allocation orders to the petitioner from Mancherial District to Nirmal District without any application of mind and without examining any of the records simply in the cyclostylic manner it was rejected, the said action of the respondents is as highly illegal arbitrary, unreasonable, non application of mind and also in violation of principles of natural justice and also in violation of Art.14, 16 and 21 of the Constitution of India and declare the same as bad-in-law and set aside the same and consequently direct the respondents to consider the case of the petitioner for re-allocation from Mancherial District to Nirmal District by considering his seniority on par with his juniors and also by taking into present vacancy position and in any clear vacancies in Nirmal District

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri C RAJA SEKHAR REDDY Advocate for the Petitioner, GP for Services I who takes notice to respondent Nos.1 to 5, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
