WHEREAS the Petitioner above named through his Advocate Sri S Viplav Simha Reddy presented this Writ Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, aggrieved by the impugned action of the respondents in allotting the Petitioner to new Local Cadre of Narayanpet which is contrary to his preferential option and seniority vide proceedings no. ES/ES/MA/NARA/LOFE/0007 dated 21-12-2021 and further in passing the rejection orders vide Memo. No. Spl/ Secretary Peshi/ 2021-34, dated 10-01-2022 despite availability of vacant posts being illegal, unjust, arbitrary and violative of Articles 14 and 16 of the Constitution of India and also contrary to the Telangana Public Employment Organization of Local Cadres and Regulation of Direct Recruitment Order 2018 and Guidelines issued in G.O.Ms. No. 317 General Administration (SPF-I) Department Dated 06.12.2021 and consequently set aside the impugned orders, dated 21.12.2021 and 10-01-2022 by directing the Respondents to allot the Petitioner to the Ranga Reddy/Mahbubnagar as per his option on priority and as per his seniority in accordance with Rules;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri S Viplav Simha Reddy Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
