WHEREAS the Petitioner above named through his Advocate Sri MUMMANENI SRINIVASA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or Direction more particularly one in the nature of Writ of Certiorari, to declaring the impugned orders passed by the 2nd respondent dt.03.02.2021 passed in the Special Tribunal New Case No.42/2021 on the file of the Court of The Special Tribunal, Kothagudem, Bhadradi Kothagudem District, without issuing any notice either to petitioner or to his counsel and without communicating the same, since the petitioner voluntarily approached the Special Tribunal on 08.08.2022 and received the copy personally, the 2nd respondent closed the Revision inspite of the 6th respondent obtained fake

Pattadar passbook, without digital signature of the Tahsildar in respect of the Petitioner's Agricultural Patta land in Sy.No.39/2AA to an extent of Ac.2-00, land in Sy.No.35/5 to an extent of Ac.1-55 cents and land in Sy.No.84/4 to an extent of Ac.1-10 of Kothapally(Z) village, Charla Mandal, Bhadradi Kothagudem District, without cancelling the petitioner's new pattadar passbooks by the Tahsildar is illegal and void and opposed to Articles 14, 19, 21 and 300 A of Constitution of India, including the orders passed by this Hon'ble Court in WP(PIL).No.20 of 2021 dt.02.03.2021 and consequently to direct the 2nd Respondent/Special Tribunal to pass an appropriate orders by giving hearing opportunity to all concerned parties by issuing notices and by following the procedure as per law in respect of the cancellation of the Pattadar Passbook issued in favour of the 6th respondent in respect of the petitioner's land in question

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri MUMMANENI SRINIVASA RAO Advocate for the Petitioner, GP for Revenue who takes notice to respondent Nos.1 to 5, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
