WHEREAS the Petitioner above named through his Advocate SRI N MANOHAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction, more particularly one in the nature Writ of Mandamus, declaring in action of Respondents No.1 to 4 in not incorporating petitioner name in the Dharani portal in respect of land in survey No.10/8 admeasuring Ac. 0.16 GTS situated at Bollaram village, Jinnaram Mandal, Sangareddy District, pursuant to Application No.RC2100005002 in Dharani portal followed by reminder on 16.08.2022 as illegal, arbitrary and in violation of principles of natural justice and contrary to the provisions of A.P Rights in Land and Pattadar Pass Books Act 1971 and consequently to direct the respondents 1 to 4 to incorporate petitioner name in Dharani portal in respect of land in survey No.10/8 admeasuring Ac.0.16 GTS situated at Bollaram village, Jinnaram Mandal, Sangareddy District, pursuant to Application No.RC2100005002 in Dharani portal and followed by representation on 16.08.2022;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri N MANOHAR Advocate for the Petitioner, GP FOR REVENUE who takes notice for the respondent nos. 1 to 4, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

ORDER

Notice before admission.

Learned Government Pleader for Revenue takes notice on behalf of respondent Nos.1 to 4.

Learned counsel for the petitioner is permitted to take out personal notice on respondent No.5 by RPAD and file proof of service.

Post on 10.10.2022 in List.

A perusal of the material on record shows that the Special Tribunal allowed the appeal filed by the petitioner by setting aside the mutation proceedings issued in favour of the petitioner. However, the grievance of the petitioner is that the name of the petitioner is not being restored in the revenue records and not updated on online Dharani Portal in spite of the orders passed by the Special Tribunal by order dated 30.06.2021.

In these circumstances, pending further orders, respondent No.4 is directed not to entertain any transaction of whatsoever in nature in respect of the subject land, at the instance of respondent No.5, till the next date of hearing.
