WHEREAS the Petitioner above named through her Advocate SMT B RAJESWARI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction, more particularly one in the nature of a Writ of Mandamus declaring the action of respondents in issuing the Notice vide Proc No.A1/Bank Linkage/2019-1 dated 31/03/2022 calling for explanation without providing relevant documents for giving explanation and not releasing the subsistence allowance from that date of suspension per Sec. 8.2 (vi) of HR Policy to Mission for Elimination of Poverty in Municipal Areas (MEPMA) employees as unjust, arbitrary and violative of Articles 21 and principles of natural justice and consequently direct the respondents to release the subsistence allowance;
