WHEREAS the Petitioner above named through its Advocate SRI.S.SURENDER REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly a Writ of Mandamus by declaring the action of the 2<sup>nd</sup> respondent in trying to shift the A4 Liquor Shop no.3 of respondent no.6 established under name and Style of Sri Laxmi Wines, Cherial Municipality, Siddipet District Vide G.S1.No. SDP 069 near to shop No.4 of the petitioner vide G.S1.No. SDP 070, situated at premises bearing Plot No.46 in Sy.No. 984, Cherial Municipality, Siddipet District without considering the representation/objections submitted by the petitioner is nothing but illegal, arbitrary, abuse of process of law and is a clear case of violation of principles of natural justice and contrary to the Provisions of Telangana Excise Act and Rules therein and consequently direct the 2<sup>nd</sup> respondent not to grant permission to the 6th respondent for shifting of A4 liquor shop no. 3, G.S1.NO. SDP 069, Cherial Municipality, Siddipet District near to the petitioner A4 Shop No. 4, G.S1.No. SDP 070, situated at premises bearing Plot No.46 in Sy.No. 984, Cherial Municipality, Siddipet District by considering the representation/objection submitted by the petitioner, in the interest of justice.;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri.S.SURENDER REDDY Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
