WHEREAS the Petitioner above named through her Advocate SRI R R KALYAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of writ of mandamus declaring the action of the respondents in not considering the objection dated 28-04-2022 filed by petitioner and pay compensation under the Act 30 of 2013 to the unofficial respondent for the agricultural land in Sy. No. 78/A/3 an extent of Ac. 1-04 Gts. out of Ac. 2-00 Gts. situated in Yatalakunta Village, Sathupally Mandal, Khammam District as illegal, arbitrary and against to principles of natural justice and consequently direct the respondents to consider petitioner objection dated 28-04-2022 and pay compensation under the Act 30 of 2013 to petitioner or to refer to Land Acquisition Authority constituted under Act 30 of 2013;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri R R KALYAN Advocate for the Petitioner, directed issue of notice to the Respondent 6 herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to pay the compensation to the 6th respondent in respect of agricultural land in Sy. No. 78/A/3 an extent of Ac. 1-04 Gts. out of Ac. 2-00 Gts. situated in Yatalakunta Village, Sathapally Khammam District as notified u/S. 11(1) of the Act 30 of 2013, pending disposal of the WP No. 34937 of 2022, on the file of the High Court.

In the circumstances, there shall be interim direction to respondent No.3 not to pay compensation to respondent No.6 in respect of agricultural land to an extent of Ac.1.04 gts in Sy.No.78/A/3 situated at Yatalakunta Village, Sathupally Mandal, Khammam District. However, the acquisition proceedings may go on.

Meanwhile, learned Assistant Government Pleader for Land Acquisition shall get instructions.
