Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, one more particularly in the nature of Writ Mandamus. a) Declaring the action of the Respondent No.2 in issuing show cause notice bearing no.512 -2/ ACP/ TPS/ C-16/GHMC/ 2022 dated 21/01/2022 as bad, arbitrary, illegal, violative of Principles of natural Justice and violative of Article 14, 21 and 300A of Constitution of India and also contrary to HMC Act, 1955. b) Consequently set aside the show cause notice bearing no 512 - 2/ACP/ TPS/ C - 16/ GHMC/ 2022 dated 21/01/2022.

IA NO: 1 OF 2022:

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents herein not to take any coercive steps against the Petitioner including demolishing of the existing structures i.e., toilets undertaken by the Petitioner, pending disposal of WP.No. 3717 of 2022 on the file of the High Court.

The Petition coming on for hearing upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri R.Anurag, Advocate for the Petitioner and of Sri Pasham Krishna Reddy – S.C. for the Respondent No.2, the Court made the following
