WHEREAS the Petitioner above named through his Advocate SRI T VIJAY HANUMAN SINGH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondent No. 4 in deleting the name of the father of writ petitioner in Sy. No. 62/D measuring Acres 6.00 guntas, and recording the names of the Respondent No. 5 and 6 in the revenue records, without following the procedure prescribed under the Act, 1971 (since repealed) and Rules, 1989 and direct the Respondent No. 3 to restore the entry in the revenue records i.e. 1-B and Pahani in respect of lands in Sy. No. 62/D measuring Acres 6.00 guntas, situated at Kunuru Village of Zaffargadh Mandal Mandal, Jangaon District (erstwhile District of Warangal) and consequently to direct the 4th Respondent not to exercise the powers vested in him and not to allot any time to the Respondent No. 5 and 6 as per Telangana Rights in Land and Pattadar;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri T VIJAY HANUMAN SINGH, Advocate for the Petitioner, directed issue of notice to the Respondent Nos.5 and 6 herein to show cause as to why this WRIT PETITION should not be admitted.
