Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ order or direction more particularly one in the nature of writ of Mandamus declaring the action of the 2nd and 3rd respondents in not considering the representation of the petitioner dated 6-1-2022 and not issuing the pattadar pass book of the petition in respect of the land admeasuring Ac. 9.27gts in Sy.No. 130 situated at Inugurthy village, Kesamudram Mandal, Mahabubabad district as illegal, arbitrary, unjust, unreasonable and contrary to the Art 14 of the Constitution of India and consequently direct the respondents- 2 and 3 to issue pattadar pass book to the petitioner in respect of the land admeasuring Ac. 9.27gts in Sy.No. 130 situated at Inugurthy village, Kesamudram Mandal, Mahabubabad district duly considering the representation of the petitioner dated 06-01-2022 in the interest of justice.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents- 2 and 3 to issue pattadar pass book to the petitioner in respect of the land admeasuring Ac. 9.27gts in Sy.No. 130 situated at Inugurthy village, Kesamudram Mandal, Mahabubabad district duly considering the representation of the petitioner dated 06-01-2022 in the interest of justice pending disposal of the above writ petition.

WRIT PETITION No. 5533 of 2022

ORDER:

Heard the learned counsel for the petitioner and the learned Government Pleader for Revenue appearing for the respondents. With their consent, the Writ Petition is disposed of at the admission stage.

2. The main grievance of the petitioner is that respondent Nos.2 and 3 are not considering her representation dated 06.01.2022 and not issuing pattadar passbook to her in respect of the subject land situated at Inugurthy Village, Kesamudram Mandal, Mahabubabad District.

3. Learned Government Pleader states that if the petitioner makes an application through *online* in Dharani Portal, the same will be considered and necessary orders will be passed by the authorities concerned, in accordance with law.

4. Having regard to the above made submissions, without going into the merits or demerits of the case, the Writ Petition is disposed of directing the petitioner to make an application to the respondent No. 2 for issuance of pattadar passbook, through *online* in Dharani Portal, within a period of two weeks from the date of receipt of a copy of this order. On such application being filed, the respondent No. 2 shall pass necessary orders thereon, strictly in accordance with law, as expeditiously as possible, preferably, within a period of eight

weeks thereafter, duly putting all the interested persons on notice and considering the objections, if any.

Pending miscellaneous petitions, if any, shall stand closed.

There shall be no order as to costs.
