Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents, particularly the 3rd respondent herein in not conducting survey and demarcation of the different extents of land bearing Sy.Nos.1 to 9 and 11 to 25, situated at Peerancheru Village, Gandipet Mandal, Ranga Reddy District, on the application of the petitioner dated. 29.09.2021 is illegal, arbitrary, unjust and violation of principles of natural justice and against the provisions of Survey and Boundaries Act, 1923, and the Rules made thereunder, and consequently direct the respondents 2 and 3 to conduct survey and demarcation and fix boundary stones surrounding different extents of land of the petitioner bearing Sy.Nos.1 to 9 and 11 to 25, total admeasuring Ac.125-00 Gts., situated at Peerancheru Village, Gandipet Mandal, Ranga Reddy District.
