The impugned detention order *vide* SB(l) No.296/PD-7/HYD/2021 dated 01.11.2021, passed by the respondent No.2, and the consequential confirmation order, *vide* G.O.Rt.No.197 General Administration (Special (Law and Order)) Department, dated 28.01.2022, passed by the Principal Secretary to Government, General Administration (Special (Law and Order)) Department, Government of Telangana, are hereby set aside. The respondents are directed to set the *detenu*, namely Goru Singh @ Goru S/o. late Bansi Singh, at liberty forthwith, if he is no longer required in any other criminal case.
