Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or Order or Direction more in the nature of the Writ of Mandamus by declaring the action of the Respondents in proposing to disconnect the electricity service connection of the petitioner bearing SC No. 21801-43243 with Unique Service No. 14721440 situated at House No. 1-5-81/23 in Sy. No. 156 situated at Ganesh Nagar, Jagtial Town, Jagtial District without considering the representation dated 17/02/2022 of the petitioner is illegal, arbitrary and against Electricity Act, 2003 and against the principles of natural justice, consequently direct the Respondents No. 3 and 4 not to disconnect the electricity service connection of the petitioner bearing SC No. 21801-43243 with Unique Service No. 14721440 in respect of the property House No. 1-5-81/23 in Sy. No. 156, Ganesh Nagar, Jagtial Town, Jagtial District.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents No.3 and 4 not to disconnect the electricity service connection of the petitioner bearing SC No. 21801-43243 with Unique Service No. 14721440 in respect of the property House No. 1-5-81/23 in Sy. No. 156 situated at Ganesh Nagar, Jagtial Town, Jagtial District pending disposal of the writ petition otherwise the petitioner would be put irreparable loss and harm.

ORDER:

Heard the learned counsel for the petitioner, the learned Government Pleader for Energy for respondent No.1, and Sri Zakir Ali Danish, the learned Standing Counsel for TSNPDCL, appearing for respondent Nos.2 to 4. With their consent, this Writ Petition is being disposed of at the stage of admission.

This writ petition is filed seeking to declare the action of the respondents in proposing to disconnect the electricity service connection to the subject property situated at Ganesh Nagar, Jagtial Town and District, without considering the representation of the petitioner dated 17.02.2022, as illegal and arbitrary.

The learned Standing Counsel, on instructions, has stated that respondent Nos.2 to 4 are not taking any steps to disconnect the power supply to the subject property, as alleged by the petitioner, and that the present writ petition has been filed on mere apprehension. Learned Standing Counsel further states that in case, respondent Nos.2 to 4 intend to disconnect the electricity service connection to the subject property, they will do it in accordance with law.

In view of the above made submissions, the grievance of the petitioner stands redressed and the Writ Petition is closed.

The miscellaneous petitions pending, if any, shall also stand closed. There shall be no order as to costs.
